A foreclosure summons is a legal document issued by the court once the lender starts the foreclosure that notifies you of the case and requires an answer. You only have a specific period of time, as set by the court system, to file your response before the court moves the foreclosure forward.

When you need more time to respond to a pleading filed in a foreclosure case in Florida, you can request an extension of time to respond. You have 20 days to respond to a complaint filed against you, and if you do not answer within the 20 days, the plaintiff – the person suing you – will move the court to enter a default judgment against you.

Even if you are already in the process of working out a solution with your bank, you may receive formal (legal) notice that the foreclosure process has begun. If you live in Florida, you only have 20 days to file and answer to their complaint. Lis Pendens – this is a legal document filed with the county land records to give the public, other lienholders, and homebuyers notice of the pending foreclosure lawsuit.

### Adding Affirmative Defenses When Responding to a ...

Pursuant to section 702.015, Florida Statutes (2013), a certification of possession of the original promissory note must be filed contemporaneously with the Complaint (form 1.944(a)) or, in the event that the plaintiff seeks to enforce a lost, destroyed, or stolen instrument, an affidavit setting forth the facts required by law must be attached to the complaint (form 1.944(b)).
