The priests of the archdiocese are covered under a separate pension plan that has a different funding formula, according to John Bierbaum, the archdiocese's chief financial officer. Two main causes Bierbaum explained that while the pension plan was over-funded in 2008, by 2009 the market collapse meant the pension fund was only 61 percent funded, a \$38.8 million shortfall.
