Thereafter the appointment of directors is usually covered by the company's articles of association as the Companies Act 2006 is largely silent on the procedure. Article 17 of the model articles for private limited companies allows for appointment either by the board of directors or by ordinary resolution of the shareholders.

Generally, a new director must be appointed by the shareholders of a company.
