SECRETARIAL STANDARD ON PASSING OF RESOLUTIONS BY ...

No Company can use Circular Resolution to escape the holding of Minimum Number of Board Meetings. Resolutions and items of business should not be passed through circular resolution, where the Act and applicable rules expressly provide that such items of business should be transacted only at duly convened Board Meeting.

Board Resolution Format Resignation of Company Secretary CS

Yes you can file DIR-12 for resignation of director as DIR-12 is the responsibility of company and DIR-11 is the responsibility of Director who resigns. Refer Sec 168 with Rule 15 and 16 of Companies (appointment and Disqualification of Directors) Rules, 2014.
