legal with a New York Pistol License (NYPL). The minimum age is 21, with the exception of honorably discharged members of the military, who can be any age.

Colorado Gun Laws | Colorado State Patrol - CSP

Concealed carry is legal in Colorado for residents with a Colorado permit to carry a concealed weapon (CCW) and non-residents of states with which Colorado has reciprocity agreements. CCW permits can be issued to any resident at least 21 years old and not prohibited by law from possessing a firearm.

In addition, per § 5-73-120(c)(8), it is permissible to carry a weapon under this section if, at the time of the act of carrying the weapon, the person is in possession of a concealed handgun has a valid Arkansas license to carry a concealed handgun or a permit from a state Arkansas honors, and is not in a prohibited place. Without a permit, firearms need to be unloaded and cased.

The Act permits the nationwide carrying of concealed handguns by qualified current and retired law enforcement officers and amends the Gun Control Act of 1968 (Pub. L. 90-618, 82 Stat. 1213) to exempt qualified current and retired law enforcement officers from state and local laws prohibiting the carry of concealed firearms.

A Colorado resident cannot legally carry concealed in-state using a nonresident permit issued by any other state. When traveling with a Colorado permit, it is advisable to contact the state you are visiting to confirm reciprocity and to review that state's firearms laws.

Illinois concealed carry laws are far newer than in most states. In fact, the state is the last in the nation to allowed concealed carry permits; first allowing the law to go into effect after July 9, 2013. State Police were given 180 days to come up with the new laws, and they are as follows:
