Over the past three years, SARS has been modernising and simplifying tax processes in line with international best practice. In terms of the Income Tax Act 58 of 1962, employers are required to:

- Deduct the correct amount of tax from employees
- Pay this amount to SARS on a monthly basis using the new Monthly Employer Declaration form (EMP201)

Otherwise call SARS ZA on 0800 00 7277 (0800 00 SARS), provide your ID number and some other security details and they will restore access to your eFiling. STEP 2: Generate your ITR12 tax return Make sure that your name appears at the top under Taxpayer List just in case you have logged onto someone else's SARS eFile page.

We recommend registering for eFiling or using the [email protected] application, both available from the SARS website, to submit your EMP201s. ### EMP201 : SimplePay

The amounts deducted or withheld by you must be paid to SARS on a monthly basis by completing the EMP201. Information to complete the declaration, is available from your payroll company by printing the EMP201 report.
