Sample APA Annotation. The annotation above both summarizes and assesses the book in the citation. The first paragraph provides a brief summary of the author's project in the book, covering the main points of the work. The second paragraph points out the project's strengths and evaluates its methods and presentation.

Formatting an Annotated Bibliography. The format for an annotated bibliography is similar to that of a research paper. Use one-inch margins on all sides; note "space before" and "space after" should be set to zero. Double space your entries; Alphabetize each entry; Hanging indents are required for citations:

If you are writing an annotated bibliography with many sources, it may be helpful to divide the sources into categories. For example, if putting together an extensive annotated bibliography for stem cell research, it might be best to divide the sources into categories such as ethical concerns, scholarly analyses, and political ramifications.
