When Army property is lost or damaged, financial responsibility can fall upon the Soldier or Civilian to whom the property was issued. Financial Liability Investigation of Property Loss, or FLIPL, is the procedure the Army uses to recover the cost of lost or damaged property.

### Questions about a Financial Liability Investigation for a ...

For most government property, the amount for which a Soldier could be held liable is capped at one month's base pay. So, for example, if a FLIPL determines that a Soldier is responsible for losing a boiler - yes, this can happen - the Soldier will not be held liable for the full amount of the boiler but only one month of his base pay.

### SOLDIER'S GUIDE TO FINANCIAL LIABILITY INVESTIGATION OF ...

A FLIPL is a Financial Liability Investigation of Property Loss, as outlined in Army Regulation 735-5 on Property Accountability Policies. If government property is lost, damaged or destroyed (LDD), a FLIPL will take place to determine who is at fault for this loss.

A FLIPL is required to be initiated due to the nature of the loss. So it may not be his targeting you, but making sure his command is cleaned up administratively before digging in. That's a good thing. The BC sounds like the appointing authority and the BDE CDR will likely approve the FLIPL.

INSTRUCTIONS : FINANCIAL LIABILITY INVESTIGATION OF PROPERTY LOSS (Form DD 200) A DD Form 200 is a Department of Defense form used for the investigation of financial liability from the loss of department of defense property. Its primary purpose is to assess financial charges for lost, damaged, or destroyed equipment or items.

### FINANCIAL LIABILITY OFFICER GUIDE

A Financial Liability Investigation of Property Loss (FLIPL) is the manner in which the Army accounts for the circumstances surrounding the loss, damage or destruction (LDD) of Government property. The FLIPL serves as documentation allowing for the adjustment of property books.

Because you did make a reasonable effort to keep your equipment secure, a FLIPL will be conducted to determine if you will be held liable for the replacement cost of the lost equipment. Liability for the missing equipment is based on whether you acted negligently with respect to the property.
