Make sure you receive these documents when you buy a car ...

A fully completed receipt or a copy of the contract (written in the same language as used in the sales presentation) stating the date of the sale and the merchant's name and address. The contract or receipt should state in ten-point bold type that it can be canceled before midnight on the third business day after the transaction took place.

Don't I have 3 days to cancel a sales contract? - Georgia

The first sentence of the contract should identify the full legal names of both the buyer and the seller and state that the contract is for the sale of a car. For example, [This is a contract made between the Seller, Joe Smith, and the buyer, Dan Jones, for the sale of Joe Smith's 1995 Honda Civic sedan.]

If your car doesn't need a title, you can provide its certificate of origin or the bill of sale (see below). A Georgia bill of sale . The Georgia Department of Revenue's Motor Vehicle Division provides a downloadable Bill of Sale (Form T-7) that you can use for this document, but you can also craft your own.

Georgia Code Section 10-1-36 outlines the debtor's options following car repossession. The lender must notify you of your rights to [redeem] the car within 10 days of repossession.
