In the 5-4 decision Supreme Court in *Everson v. Board of Education* (1947), both Hugo Black's majority opinion and Wiley Rutledge's dissenting opinion approvingly cited Jefferson's metaphorical "wall of separation between Church and State," and the court now expressly applied that idea to the states as well as to the federal government.

Separation of church and state in the United States ...

For Jefferson, separation of church and state was a necessary reform of the religious tyranny whereby a religion received state endorsement, and those not of that religion were denied rights, and even punished. Following the Revolution, Jefferson played a leading role in the disestablishment of religion in Virginia. Previously as the established state church, the Anglican Church received tax ...

Jefferson Church And State

Jefferson's reply did not address their concerns about problems with state establishment of religion — only of establishment on the national level. The letter contains the phrase "wall of separation between church and state," which led to the shorthand for the Establishment Clause that we use today: "Separation of church and state."

The Mythical "Wall of Separation": How a Misused Metaphor ...

The phrase "wall of separation between the church and the state" was originally coined by Thomas Jefferson in a letter to the Danbury Baptists on January 1, 1802. His purpose in this letter was to assuage the fears of the Danbury, Connecticut Baptists, and so he told them that this wall had been erected to protect them.

Thomas Jefferson wrote to a letter to a Baptist Church from Danbury, Connecticut, in which he explained his beliefs about federalism and the meaning of the Establishment Clause. Jefferson did not address the subject of state-sponsored churches, but assured the congregation that the federal government could not interfere with their church or offer special favors to any

particular sect.
