Only U.S. citizens and residents with temporary or permanent legal presence may apply for a Michigan driver's license. Residents who have temporary legal presence are issued a limited-term driver's license. A limited-term license is valid for only as long as the person is authorized to remain in the country.

Michigan Temporary Driving Permit or Paper License If you are a licensed Michigan driver and are arrested for OWI, the arresting officer will confiscate your driver's license. Under Michigan state law, the confiscated license must be destroyed, and in its place you will be issued a temporary driving permit.

You'll receive a temporary paper license to use until you receive your new license, which should arrive in a few weeks. If your driver's license is going to expire within 1 year, you can opt to renew it instead of replace it.

A written knowledge test is required for all those applying for a Michigan level 1 license, or temporary instruction permit if over age 18. The written test is comprised of 50 questions from the 2020 Michigan Driver's Manual and you must correctly answer at least 40 questions to pass.

Residents with a document granting them permission to drive but lacking their photograph, such as a Temporary Instruction Permit, restricted license ordered by the court or Secretary of State or a 625g paper permit, are also eligible for a state ID card. 30-Day and 60-Day Temporary Registration Permits. Some Michigan residents, including those serving in the military, may use their vehicles* only occasionally or may be out of the country for extended periods of time. Rather than purchasing or renewing a full-year license plate, these owners may buy a 30-day temporary permit or 60-day temporary permit for short-term use of their vehicle.

Issue a paper temporary license plate and place it on the vehicle. Notify the Secretary of State through the LEIN that the metal plate was destroyed and a temporary license plate was issued. A temporary license plate in this situation is valid until the court case is completed.
