As of 2010, the state of Minnesota does not contract with private prisons. The first and only private prison in the state, the Prairie Correctional Facility, was closed by its owner in 2010. The head of the agency is referred to as the Commissioner. As of 17 July 2017, the holder of this office is Tom Roy.

Community Corrections: In 1973, Minnesota legislators decided to reserve prison bed space for offenders who pose a threat to community safety. The Community Corrections Act allows for lower level offenders to serve their sentences in county jails or on public service programs in their communities.
