Section 111(6) Magistrates Court Act 1980 provides for the person who applied for a case stated to apply to the High Court for a mandatory order requiring the magistrates' court to state a case. The first draft of the statement of the case must be prepared by the Justices' Clerk and sent to the appellant and respondent within 21 days of the court serving notice that it shall state a case.

The application for permission is considered by a single High Court judge on the papers. The judge's decision and the reasons for it (Form JRJ) are served on all parties. Permission refused.
