Nevada Security Guard Requirements | Become a Security ...

Undergo a criminal history background check through the Federal Bureau of Investigation (FBI), the Nevada Department of Public Safety. Pass an exam with a score of 75% or better (only for individual applicants and qualified agent applicants) Meet the experience/education requirement required per license category; Apply for a License

Forms – Nevada

This course meets all requirements set forth by the Nevada Private Investigations Licensing Board for the individual who graduates to carry a firearm they have qualified with while performing the duties of an Armed Security Officer in lawful employment under a licensee in good standing with the State. Minimum age for attendance is 21.

ExamDates – Nevada

Las Vegas security guards must pass an online unarmed security guard exam prior to obtaining a PIRB unarmed security guard card. The test contains 30 questions. A score of 100% is required for passage; however, the test taker may retake the test as necessary and each of the questions are provided in the official study guide.
