### **Create and add a signature to messages - Outlook**

A covering letter to the bank manager has to be written for change in authorised signatory along with enclosing the resolution copy and other important documents as required by the bank viz. KYC forms duly filled in and signed with identity & address proofs of Signatories.

### **Procedure for change in bank account signatory of a company**

Are your email signature images changing size or showing much larger when you install the signature in your email client? The most common reason for email signature images changing in size is because the image resolution (in DPI) is not set to 96 DPI for Outlook, or 72 DPI for Apple Mail.. If your DPI settings are too high, you'll likely end up with an enlarged image in your email signature.
