Trade Secret Damages Section 3(a) of UTSA provides as follows: Except to the extent that a material and prejudicial change of position prior to acquiring knowledge or reason to know of misappropriation renders a monetary recovery inequitable, a complainant is entitled to recover damages for misappropriation.

A common method for preserving trade secrets in such a situation is for the trade secret owner and the other party to enter into a Non-Disclosure Agreement (NDA) of some type. If the NDA contains a time limit on its non-disclosure obligation, then the expiration of that time limit may jeopardize the trade secrets covered by the NDA.
