Care plan completion based on the CAA process is required for OBRA-required comprehensive assessments.. It is not required for non-comprehensive assessments (Quarterly, SCQA), PPS assessments, Discharge assessments, or Tracking records.. However, the resident's care plan must be reviewed after each assessment, as required by §483.20, except discharge assessments,
