In a swimming pool the colour of the lane ropes should be as follows: • Two (2) GREEN ropes for lanes 1 and 8 • Four (4) BLUE ropes for lanes 2, 3, 6 and 7 • Three (3) YELLOW ropes for lanes 4 and 5 The floats extending for a distance of 5.0 metres from each end of the pool shall be of RED colour.

However, swimming pool operators must comply with their general duties under the Health and Safety at Work etc Act 1974 and the associated regulations. Operators must make a suitable and sufficient assessment of the health and safety risks to workers and users to help decide what they must do to make their pool safe.

The Environmental Public Health (Swimming Pools) Regulations in Singapore stipulates the water quality guidelines in swimming pools. Generally, swimming pool water should be checked for chemical as well as bacteriological quality in accredited laboratories at least monthly to ensure that it is safe for people to swim in the water.
