The amendments to Texas Admin.Code § 3.586 concerning franchise tax nexus were finalized on December 20, 2019.. As amended, the regulation provides that for each federal income tax accounting period ending in 2019 or later, a foreign (non-Texas) entity with gross receipts from doing business in Texas of \$500,000 or more is subject to Texas franchise tax, even if the entity has no physical ...

The Comptroller's office has amended Rule 3.586, Margin: Nexus, for franchise tax reports due on or after Jan. 1, 2020.A foreign taxable entity with no physical presence in Texas now has nexus if, during any federal accounting period ending in 2019 or later, it has gross receipts from business done in Texas of \$500,000 or more.

A foreign taxable entity with a Texas use tax permit is presumed to have nexus in Texas and is subject to Texas franchise tax. If the entity has overcome this presumption, the beginning date is determined under subsection (g)(2)(A) or (C) of this section. (f) Economic nexus.

The threshold level of activity required for a tax nexus is generally lower than the threshold level of activity that requires registration with the secretary of state. Therefore, if the Texas Nexus Questionnaire results in a determination of "no nexus," the entity is probably not transacting business in Texas either.

Foreign or Out-of-State Entities - Secretary of State of Texas

Nexus is the amount of presence a business has in a certain location (e.g., state or city). You might have nexus in a state if you sell goods to a customer in that state. Sales tax is a pass-through tax. Businesses in specific localities or states must collect sales tax from customers at the point of sale.
