The TN Visa only applies to Citizens of Mexico and Canada. Unfortunately, permanent residents or non-citizens do not qualify. In order to have your application processed on the spot and qualify for a TN visa, you will need: Proof of your citizenship

required to prove whether a Canadian or Mexican citizen is a professional in a qualifying profession.
