LLC Member Withdrawal, Resignation or Dissociation

Resignation and Withdrawal. Each Member hereby covenants and agrees that it will not, and shall have no right to, resign or withdraw from the Company as a Member and shall not have the right to cause the expulsion of a Member and irrevocably waives any and all rights of a resigning or withdrawing member under Section 18-604 of the Act or otherwise and the right to cause such expulsion.

Resignation or Withdrawal from Membership – Organizations

A The basic position is that an employee does not have the right to unilaterally withdraw their resignation once given. The employer is entitled to consider any such request made by an employee and may decide to allow the employee to retract the resignation. However, caution may have to be exercised if, in resigning, the employee used words or actions that are ambiguous, or the employee has ...

A resigning director controls the date and time of his/her departure from the board. A resignation that takes effect at a future date may be withdrawn or postponed at any time prior to that date. The board cannot alter the date and time of another director's resignation by "accepting" the resignation prior to the effective date of the resignation.

Withdrawal of Resignation - Davis-Stirling

The employee should not be denied the opportunity to withdraw the resignation, if the " special circumstances " do exist. In the case of Kwik-Fit (GB) limited v Lineham [1992] IRLR 156, it was decided that if the employee submits his/her resignation in the heat of the moment and special circumstances exist, then the employer should investigate the matter and be sure of the employee ' s ...

Except as provided in this subchapter, upon resignation any resigning member is entitled to receive any distribution to which such member is entitled under a limited liability company agreement and, if not otherwise provided in a limited liability company agreement, such member is entitled to receive, within a reasonable time after resignation, the fair value of such member ' s limited ...

Again, it may be that only the members can fill vacancies. Allowing the withdrawal of a director's resignation would be inconsistent with this locus of membership power. Also, allowing a withdrawal would raise the issue of the director's status during the period between the time of his resignation and the time that the resignation is withdrawn.
